1. 租用人先致電 3188 4137 查詢租用日期, 接受一年前預訂 (此查詢並不視作正式租用)。租用人經遞表申請後, 如獲接納訂場, 租用人將會獲書面通知並須繳交訂金; 有關租用申請須在繳付訂金後方為落實。獲覆實訂租後, 租用場地的時間、日期等資料將不接受任何形式的更改或轉讓。  
Please call our Stadium office at 3188 4137 for vacancy checking, reservation is accepted 1 year in advance (the call is not a formal booking or reservation). Hirer should submit a booking form to Stadium. If the application is accepted, an official letter will be mailed to the applicant and deposit is required as a confirmation of booking. i.e. The booking is not yet confirmed until the deposit is made. No amendment of booking date, time nor whatsoever will be accepted after confirmation.

In case the actual tickets sales is not fully sold, Stadium will return the difference to Hirer; but the Rental Charge will not be less than the Rental Charge according to the Nature of Hirer. If using internet ticketing agent, the said additional cost will NOT include at the booking period, the Total Box Office Income will be based on internet ticketing agent sales report, and the additional charge (if any) will be deducted from the ticket income of the event.
